Two weeks ago, we shared the news that everybody has been waiting two long years to hear. In keeping with city and CDC guidance, Penn dropped its masking mandate with the exception of health care facilities and classrooms. Our campus and community continue to move closer to normalcy.

Penn arrived at this point thanks to all of you and the concerted efforts of our entire University. Of course, the most enduring lesson we have learned in this pandemic is to expect the unexpected. We will remain vigilant, keeping close tabs on the latest science and public health guidance as Penn and the world continue to meet the challenges of COVID-19. For now, thank you once again for your leadership and service in support of Penn's efforts.

At the spring Stated Meeting of the Board of Trustees, the Board approved a resolution naming Liz Magill the 9th president of Penn. President-elect Magill accepted and joined the Board, University leadership, faculty, students, and staff for a celebratory march down Locust Walk. Escorted by the Penn Band and the Quaker—with a surprise appearance by Philly Flyers mascot Gritty—the President-elect enjoyed a truly warm and memorable Penn welcome.

The Penn community is also celebrating a number of auspicious anniversaries. This Friday, Du Bois College House celebrates the 50th anniversary of its creation with a Family Reunion. In addition, the Asian American Studies Program recently marked their 25th anniversary. On behalf of the entire University, I congratulate our students, faculty, and staff on these and many other extraordinary milestones for Penn.

Amid all of this good news, the Penn community also reaches out to all those who are suffering in Ukraine during this terrible time. We announced the University's and Penn Medicine's support for humanitarian efforts in Ukraine. We created a gift page to collect donations from the Penn community and pledged to match dollar for dollar \$100K in donations—and quickly raised far in excess of our announced goal. This is in keeping with similar matching campaigns for other recent humanitarian causes, from COVID-19 relief for India to Hurricane Irma recovery for Puerto Rico. I am proud to join Dr. Jameson and the Penn community in this important effort.

I hope you all enjoyed a restful spring break, and I join you in looking forward to the rest of the spring semester.

PROVOST'S STATUS REPORT University Council March 2022

I am very pleased to congratulate Prof. Michael Horowitz, who will be taking a leave as the Richard Perry Professor and Director of Perry World House to serve in an important position with the US Department of Defense. His vision, energy, and intellectual rigor have defined the mission of <u>Perry World House</u> from its founding in 2016. Executive Director LaShawn Jefferson has agreed to assume the role of Senior Executive Director, and we will also be forming a new faculty council – led by Prof. Ezekiel Emanuel, Diane v.S. Levy and Robert M. Levy University Professor and Vice Provost for Global Initiatives – to provide even greater faculty engagement and ensure that Perry World House expands its vital role as a place for cutting-edge research and events that address the most important global policy questions. We are confident that the new leadership team will sustain the invaluable work of Perry World House, at a time when its leadership on global challenges is needed more than ever.

The Excellence Through Diversity Fund is one of the University's most important means of supporting faculty projects that promise to advance faculty diversity, equity and inclusion; promote collaborations across disciplines, departments, and/or Schools; and/or foster new understandings of the structures, policies, and programs that advance faculty diversity, equity, and inclusion. Projects are open to faculty at any rank and may include cross-School research, conferences and events, large-scale faculty development work, and projects that assess the climate for diversity and inclusion at Penn. This year's Fund also prioritizes proposals that recognize and seek to address the needs of junior faculty who have been disproportionately negatively impacted by the COVID-19 pandemic. Proposals are due by April 29, and you can consult the full <u>Call for Proposals</u> for more detailed information.

I also encourage faculty members to consider applying for an <u>Academically Based Community</u> <u>Service Course grant</u> for next academic year. These courses, which faculty and students often tell us are among their most rewarding experiences at Penn, are designed to engage undergraduate and graduate students in real-world problem-solving projects in partnership with schools and community organizations in West Philadelphia. The grants support faculty in developing new courses or adapting existing courses that combine research with school and community projects. The courses are based in the <u>Netter Center</u> for Community Partnerships, which will support the course beyond the duration of the grant by providing undergraduate work-study teaching assistants, transportation, and ongoing community partnerships. Proposals are due by April 15, and you can learn more about <u>previous ABCS courses</u> on the Netter Center website.

I look forward to working together as we head into the great spring season ahead.

- Our Programming division remains ambitious and diligent with plans for large-scale in-person events to fulfill our ongoing mission towards rebuilding our community, while continuing to apply best practices for COVID safety in accordance to evolving policies. - Our fourth and final round of Student Group Event Funding and Green Leaf Funding for the academic year is open we are proud to have supported the returning activities of existing student groups and help support the founding of tens of new student groups.
